RESPONSIBLE

Processing of personal data

JVP.org complies with the provisions of Law 15/1999 of 13 December 1999 on the Protection of Personal Data and its implementing regulations.

The User does not provide any personal information merely by visiting the website, nor are you obliged to provide such information.

The information you provide will always be requested in advance and must be provided with your unambiguous and informed consent.

Under no circumstance will JVP.org request or store personal data concerning ideology, trade union membership, religion, beliefs, racial or ethnic origin, or sex life.

With the exception of fields where it is expressly stated otherwise, replies to questions about personal data are voluntary. Choosing not to reply to those questions does not affect the quality of the services that you request. If you do not fill in fields that are mandatory or provide incorrect data, JVP.org will not be able to provide the services you request.

The personal data that you provide in the forms you fill in will be processed automatically and added by JVP.org to files for which it has registered ownership with the Data Protection Agency. JVP.org will take the safety measures required by the order in force to ensure confidentiality and use in accordance with the purpose of collecting this data.

The purpose of these files is to manage, administer and provide the services or products that you request or purchase on the JVP.org website; to facilitate the compliance and implementation of services you may request; to learn more about your tastes and opinions regarding our services and adapt our services to your preferences, and to offer new services and send you information concerning new products and promotions.

The purpose of the files owned by Thermo Lamp is to manage contractual relationships with users and to carry out promotional and advertising activities of its own or third parties using any medium, including sending commercial messages by SMS, email, post, etc., based on the study and segmentation of data collected when users browse the website, data that users provide in any forms they fill in, and data gathered during the course of the business relationship or delivery of products purchased.

Only one User can access the website at any one time with the same ID and password, thereby prohibiting concurrent access under the same ID. The User agrees to notify us immediately of any unauthorised use of his email address, ID and Password, and any other security breach that he is aware of.

Minors

JVP.org undertakes always to request the express consent of the parents or guardians of minors who want to register as a website User. Notwithstanding the above, the COMPANY will under no circumstance be liable for any damages that may arise in the event that a minor does not provide accurate information about his age when registering.
